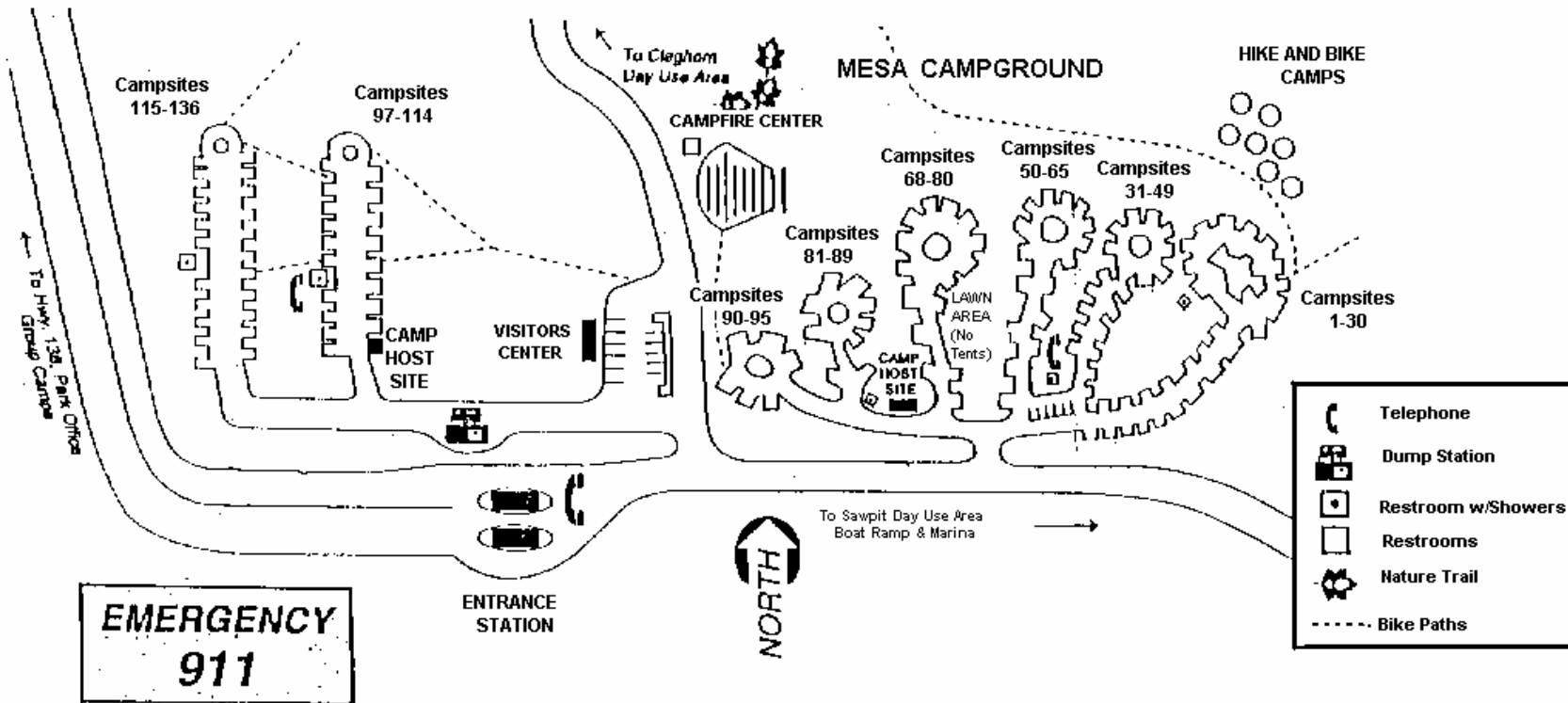

RULES & REGULATIONS

CAMPING

- You are responsible for knowing all rules and regulations.
- Campsite fee includes 1 vehicle.
- There is an additional fee for extra vehicles, pets and boats.
- Each site may have up to 8 persons.
- Reservations are strongly advised and can be made by calling PARKNET at 1-800-444-PARK.
- All vehicles must remain on the pavement.
- No day-use vehicles in the campground.
- Picnic tables are not to be moved from one campsite to another.
- No tents on the grass area.
- No wood gathering. Wood is available for purchase at the entrance station and camp-host site.
- No electronic equipment may be used which emits a sound beyond the immediate campsite.
- Ground fires are permitted only in the fire rings provided.
- Quiet hours are from 10:00 PM to 6:00 AM.
- Generators emitting noise beyond the campsite may not be operated between the hours of 8:00 PM and 10:00 AM.
- A dump station is located adjacent to the entrance station.
- Pets must be leashed (6' or less), caged or in a vehicle at all times and may not be left unattended.
- Check-out time is 12:00 Noon/Check-in time is 2.00 PM.

DAY USE/BOATING

- No diving within the State Park System.
 - Firearms (loaded or unloaded) are prohibited.
 - All fireworks are prohibited.
 - All plants and animals are protected.
 - You are responsible for knowing and obeying all boating laws.
 - Mooring to or coming in contact with any buoy or buoy line is prohibited.
 - No fires or barbecues are allowed in the boat-in areas.
 - Towing of inflatable devices is prohibited in the open zones.
 - All boats must be off the lake at official sunset.
 - Swimmers should swim only in the swimming areas.

- Noisy or vicious pets will be evicted.
 - Pet owners are responsible for cleaning up after their pets.
 - We often feel a sense of security in our parks, but don't become an easy target for a thief. Protect your valuables by keeping your vehicle locked when unattended and keeping your valuables in your tent or camper at night. Every year ice chests, cameras and bicycles are stolen when basic precautions could have prevented the theft..

SILVERWOOD LAKE STATE RECREATION APEA is a wintering site for Bald Eagles. If you are interested in attending a Bald Eagle Tour (Jan. - Mar.) contact the park. Summer interpretive activities include the following programs: Campfire Talks, "Coffee with the Ranger", Junior Ranger and Wild Flower Walks.
